# DEVELOPMENT WITHIN CONSERVATION AREAS AND OF LISTED BUILDINGS

The following website gives a file that can be downloaded to find detailed information concerning development of Listed Buildings and within Conservation Areas:

Development within a Conservation Area will attract more restrictions than most other places and is more likely to require planning permission. Development of a Listed Building will be likely to require planning permission, but the City of Edinburgh Planning Department will be able to offer guidance: ring 0131 529 3550 or email: planning@edinburgh.gov.uk. The download above refers on pages 9 and 10 to railings and states '... it is important to establish what the original railings were like'. There is a record of the styles of railings within the Blacket Conservation Area and this can be viewed on the Blacket Association website: <a href="https://www.blacketedin.org/">www.blacketedin.org/</a>. Within that website, click on 'Planning & Conservation', scroll down to 'Making Changes to Your Property' and, in the last line of the first paragraph, click on 'railings'.

Listed Building consent must be obtained where proposals will alter the character of the Listed Building, regardless of its category or whether the work is internal or external. If you are not sure whether you live in a Listed Building or are unsure as to the extent of the Listing, go to:

http://www.edinburgh.gov.uk/info/20065/conservation/244/listed buildings/. Note that Listing may include more than the house itself: for example, boundary walls. Use the map to click on the property concerned and a 'text square' will appear, which includes a link to Historic Scotland's detailed information. Use of the address panel to identify the property on the map is not recommended as this appears to give limited information.

The Character Appraisal for the Blacket Conservation Area identifies the essential character of conservation area. A copy of this Character Appraisal can be viewed by entering the following URL and opening the downloaded pdf:

# **BLACKET SHRUBBERY WORKING PARTY**

It was decided that we should have a further go at growing spring flowers in the Shrubbery. This has resulted in almost 3,000 bulbs being planted. We shall see what happens in 2016. A fuller report will be in the papers for the AGM.

### **NEIGHBOURHOOD WATCH**

As a relatively prosperous area, we are a high-risk target for property crime and there have been some serious recent incidents in the Blackets. In one case, a house was broken into while the owner was away on holiday. In another incident, the owners heard housebreakers attempting to break in and as a result they ran off empty-handed. Most housebreaking is opportunistic. The August Neighbourhood Watch report set out some advice on making your houses less attractive to potential housebreakers.

In a rather more unusual incident, a resident and her two children were seriously harassed by a motorist who followed them home and threatened them verbally. Eventually, the man drove off but not before his car number had been noted. The police were informed but some weeks later have not got back to our neighbour on the outcome of their enquiries. Nonetheless, most modern property crime is committed not by housebreaking but online. The dangers have been highlighted most recently by the TalkTalk cyberattack. Be very suspicious of attempts to obtain cash from you online, over the phone or on the doorstep.

# **BLACKET CARDS**

The last newsletter indicated that a second edition of the 'Blacket Cards' was now available for purchase. Each card with envelope costs only £1.25, with five cards costing £5. A free copy of each card is enclosed with the Newsletter. Anyone who wishes to buy cards can place an order with a committee member.

#### SUBSCRIPTIONS

Currently, fewer than half of Blacket residents fund the activities of the Blacket Association, which works hard on behalf of all residents. Membership costs only £5 a year and a membership form is attached for those who now wish to contribute.
